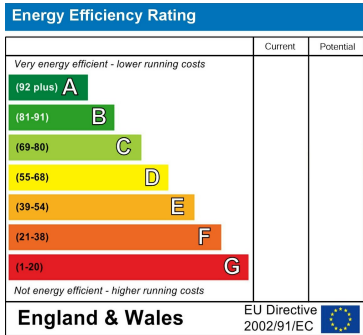
This charming terraced house is conveniently located approximately eight miles west of Bradford, ensuring easy access to local shops and public transport links.
