Description

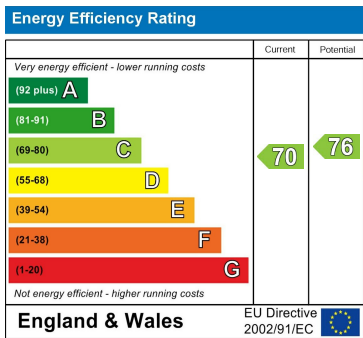
