Three piece suite incorporating had was basin, low flush w.c. and bath. UPVC double glazed window to the side and gas central heating radiator.

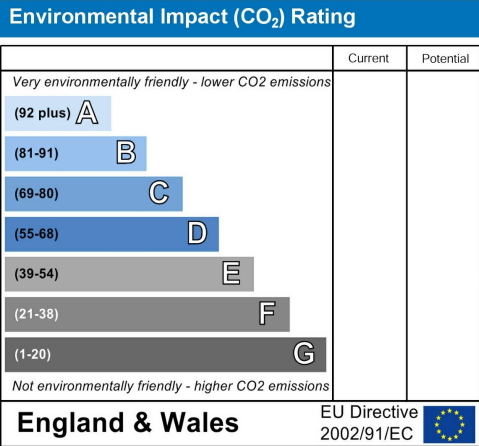
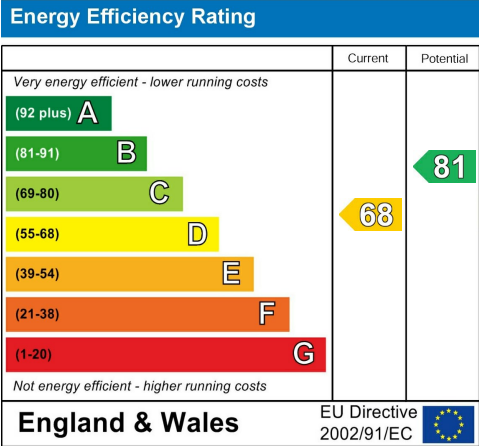


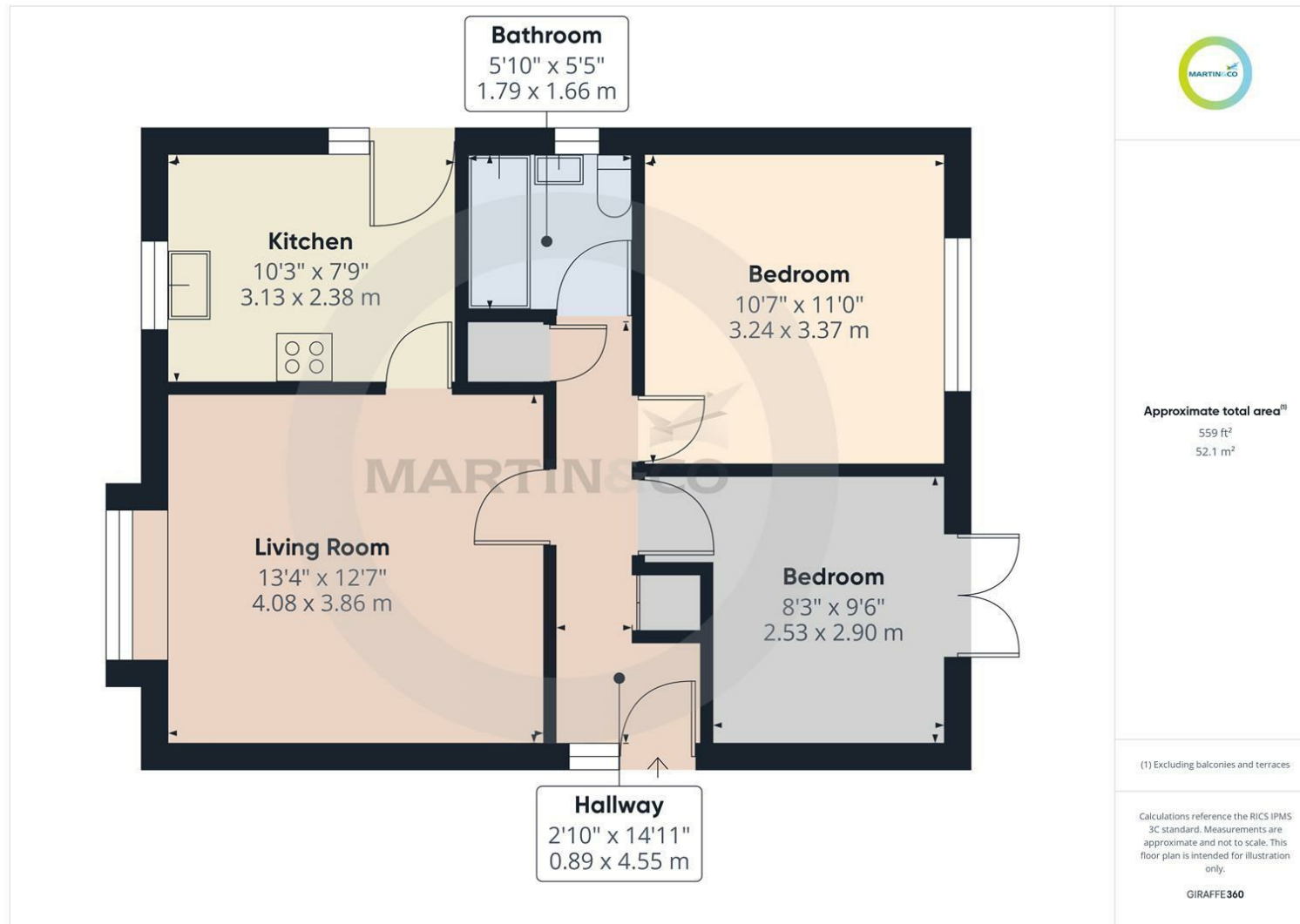
