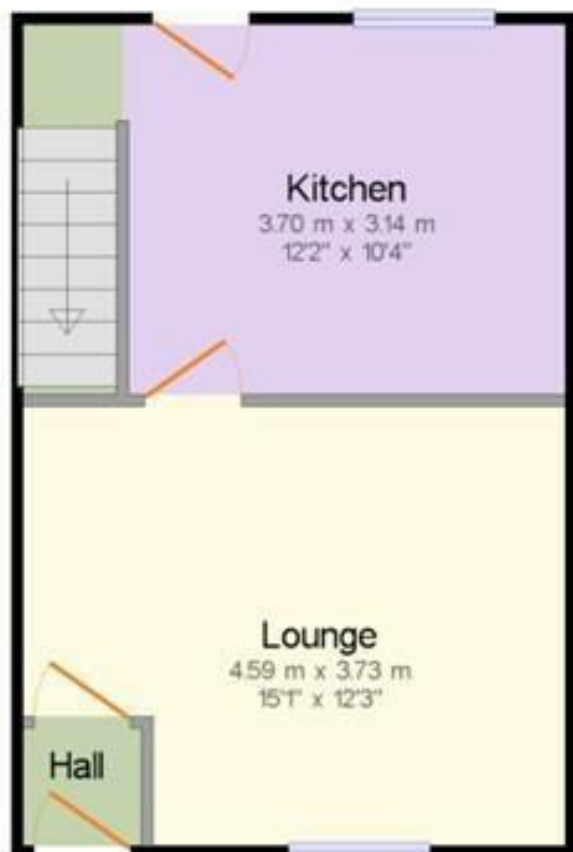

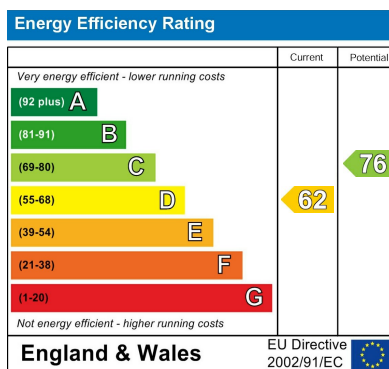




Ground Floor
