The property is situated on Woodside, in a convenient and well-established residential area within the central part of Buxton — the celebrated Georgian and Victorian spa town set high in the Derbyshire hills and widely regarded as the gateway to the Peak District National Park. Panelled bath with electric shower unit and screen over, low flush WC, pedestal wash basin and a uPVC double glazed window.

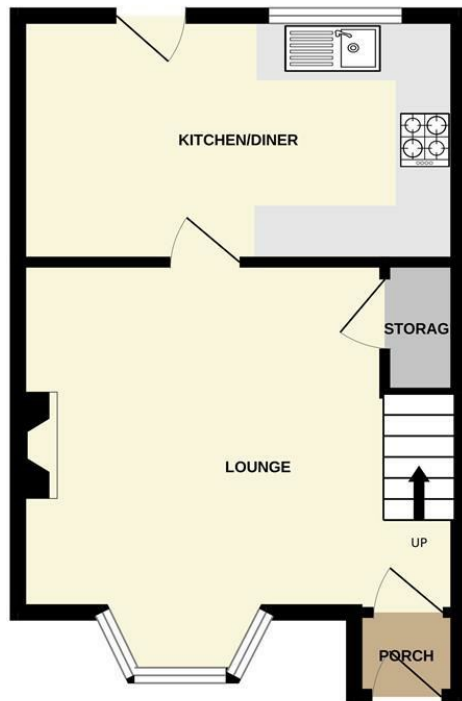
Outside

An attractive, low-maintenance rear garden laid to a paved patio area with artificial grass, together with two parking spaces.

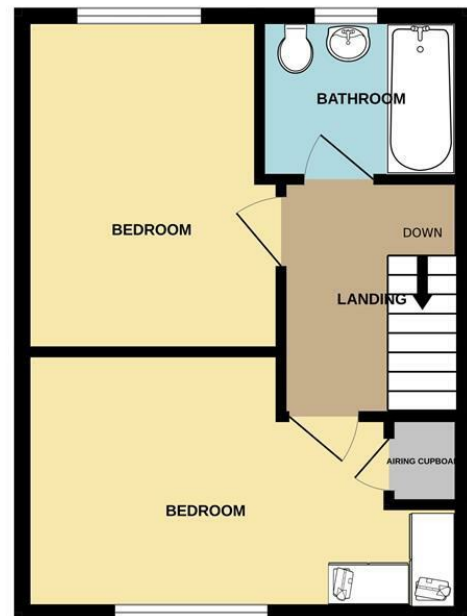
