Location

The property is situated in the popular and well-regarded Burbage area, on the south-western side of Buxton — the celebrated Georgian and Victorian spa town set high in the Derbyshire hills and widely regarded as the gateway to the Peak District National Park. Green Lane lies approximately one mile from the town centre, where an excellent range of independent retailers, High Street names, cafés and restaurants can be found around the pedestrianised Spring Gardens and The Springs Shopping Centre, alongside the renowned Opera House and the 23-acre Pavilion Gardens. The immediate area is particularly well served by schooling, with Burbage Primary School and Buxton Community School both close by, while Buxton railway station offers regular direct services to Manchester Piccadilly and the open countryside of Grin Low, the Cavendish Golf Course and the wider Peak District is right on the doorstep.
