Boasting over 1,930 Sq Ft of internal space including the integrated garage - there is huge potential to modernise and extend this characterful family home (STPP). There is a 16x13 ft bay-fronted reception room seperated by original panel doors to the formal dining room. There is a separate eat-in kitchen-breakfast room that leads onto a utility room and the 28-ft private garden.

Upstairs are four comfortable double bedrooms, an additional single or study room as well as a family bathroom and access to the loft.

Glengarry Road is enviably located for the strong transport links into The City and West End from East Dulwich station (0.3 miles) as well as the bus/cycle routes through the neighbouring Dulwich Village, Herne Hill and Peckham Rye. There are excellent primary, secondary and private school options as well as a host of gorgeous parks and green spaces. There are independent shops, bars, restaurants and coffee shops nearby on Lordship Lane, North Cross Road and Grove Vale.




Floorplan
