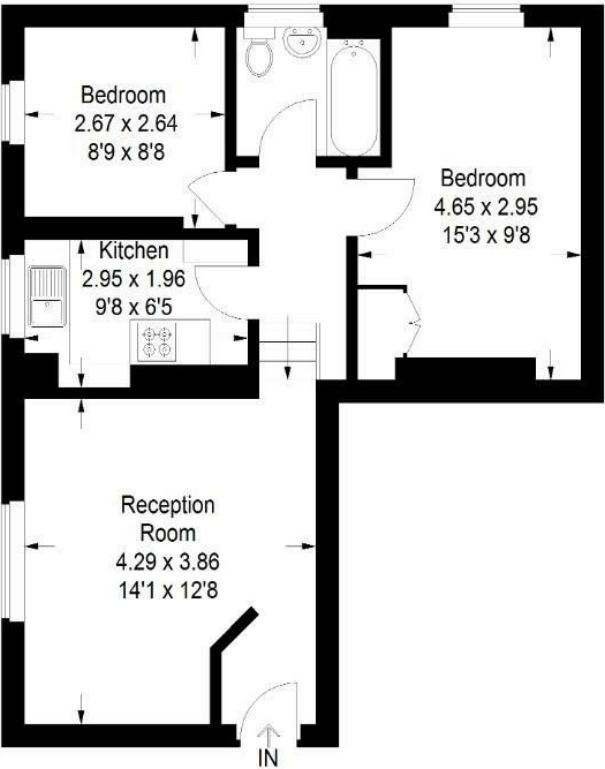

Floorplan

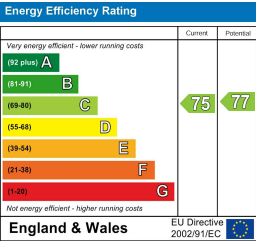
