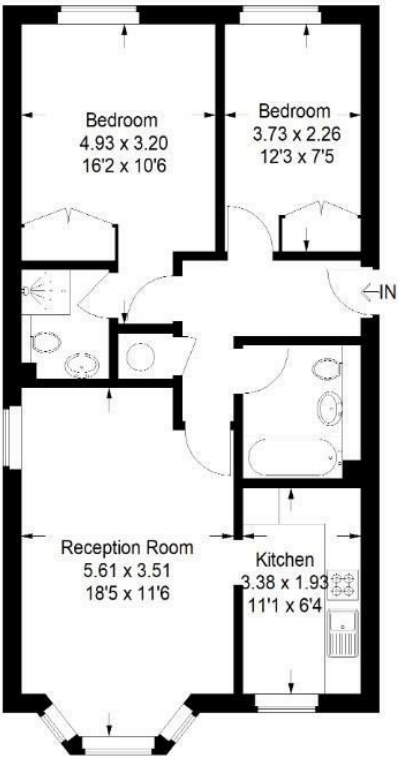

Floorplan

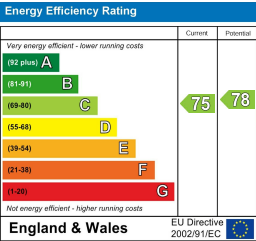
