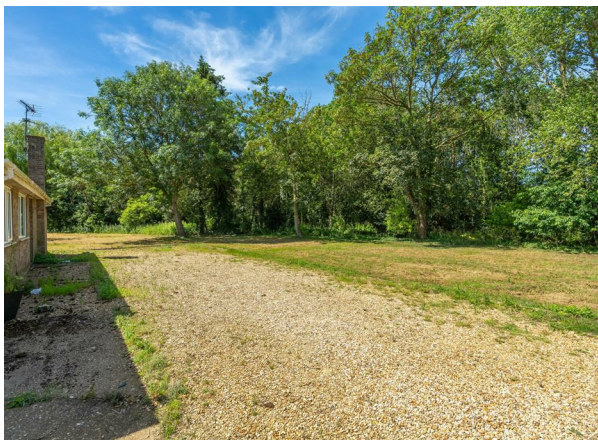

The bungalow requires a comprehensive refurbishment and should be viewed as a redevelopment opportunity. The plot size offers potential for extension – subject to planning consents.

Ruskington (approximately 2 miles / 5 minutes' drive) provides a strong range of day-to-day amenities, including a Co-op food store, independent retailers, medical centre, pharmacy, primary schooling and a railway station with regular services to Sleaford, Lincoln and beyond. The village is well regarded locally and supports a stable residential market.

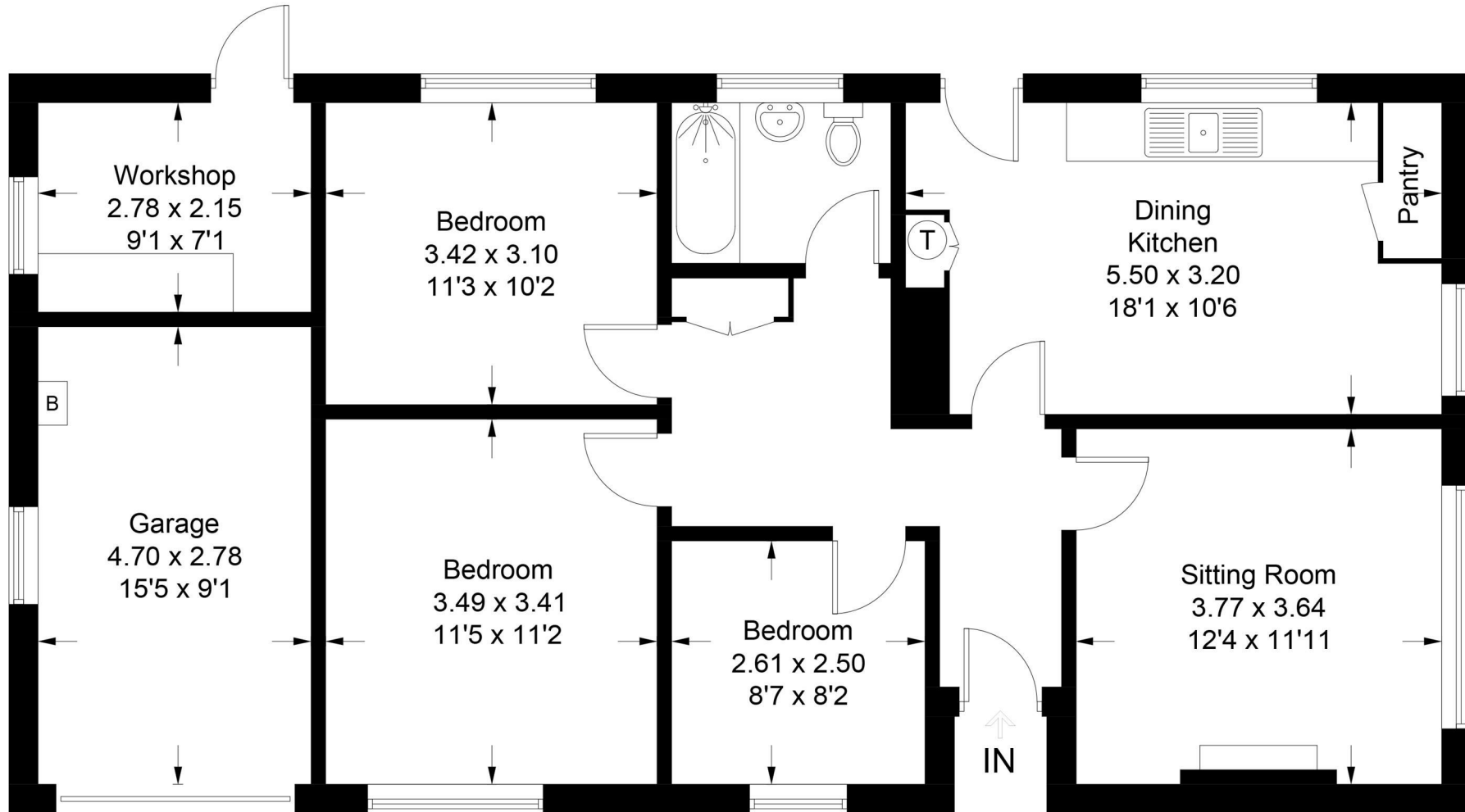

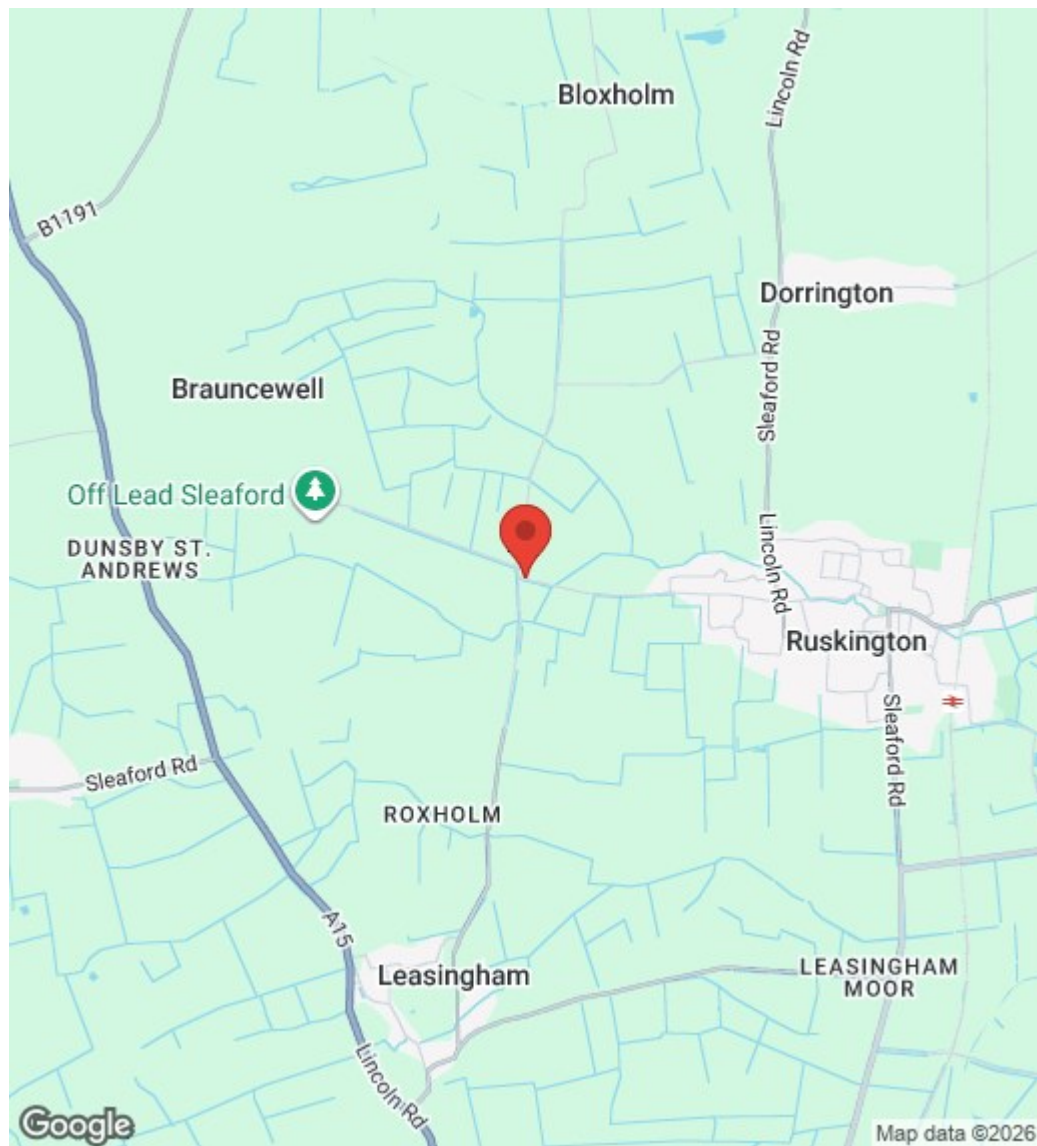
