Driveway to front providing off road parking.

#### Entrance Hall

Doors radiating off, stairs rising to first floor, double glazed window to front.

#### Lounge

15'5" x 11'0" (4.71 x 3.36)

Gas fire with surround, double glazed bay window to front, double doors open into the conservatory.

#### Kitchen

17'5" x 7'11" (5.30 x 2.41)

Variety of wall and base units, sink and drainer, double glazed window to rear, doors out to garden, central heated radiator.

#### Wet Room

8'11" x 5'1" (2.71 x 1.54)

Shower, wash hand basin, w.c, chrome heated radiator.

#### Bedroom 4

10'4" x 8'3" (3.16 x 2.51)

Double glazed window to rear, central heated radiator.

#### Utility

Double glazed window to front, plumbing for washing machine.

#### Landing

Doors off to all first floor, double glazed window to front.

#### Bedroom 1

Fitted wardrobes, central heated radiator, two double glazed window to rear.

### Garden
