Paved driveway, lawn and path leads to:

#### Entrance Hall

Door to front, central heating radiator and stairs off.

#### Lounge

11' 1" x 15' 8" (3.4 x 4.8)

Double glazed window to front, double doors to rear garden, feature fire surround and central heating radiator.

#### Kitchen

8' 10" x 10' 9" min 15' 8" max (2.7 x 3.3 min 4.8 max)

Double glazed window to front and rear, range of wall and base units with work surface over incorporating sink with mixer tap, electric hob with extractor hood over, integrated oven, tiled floor and splash backs, central heating radiator, space and plumbing for washing machine and boiler.

#### Rear Lobby

Door to rear and cupboard off.

#### Landing

Double glazed window to rear, access to loft space and cupboard off.

#### Bedroom One

8' 10" x 15' 8" (2.7 x 4.8)

Double glazed window to front and rear and central heating radiator.

#### Bedroom Two

8' 6" x 6' 6", 9' 10" (2.6 x 2.3)

Double glazed window to rear and central heating radiator.

#### Bedroom Three

7' 10" max x 7' 10" (2.4 max x 2.4)

Double glazed window to front and central heating radiator.

#### Bathroom

Bath with mixer tap and electric shower, double glazed window to front, wash hand basin with mixer tap, WC, central heating radiator and tiled walls.

Patio area and pathway, lawn, flower beds, side gate and all with fencing to enclose.

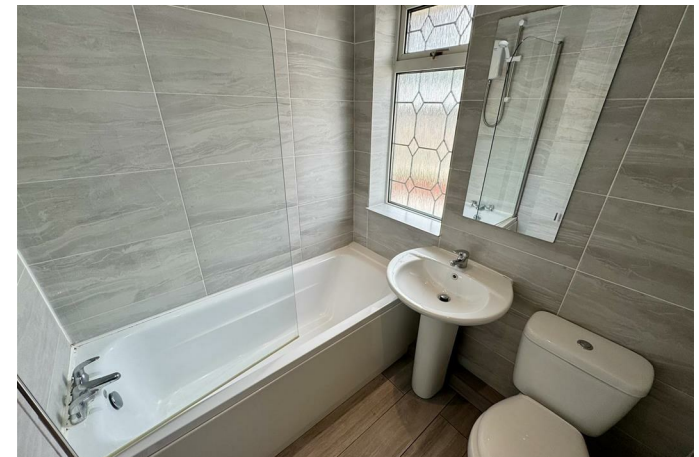

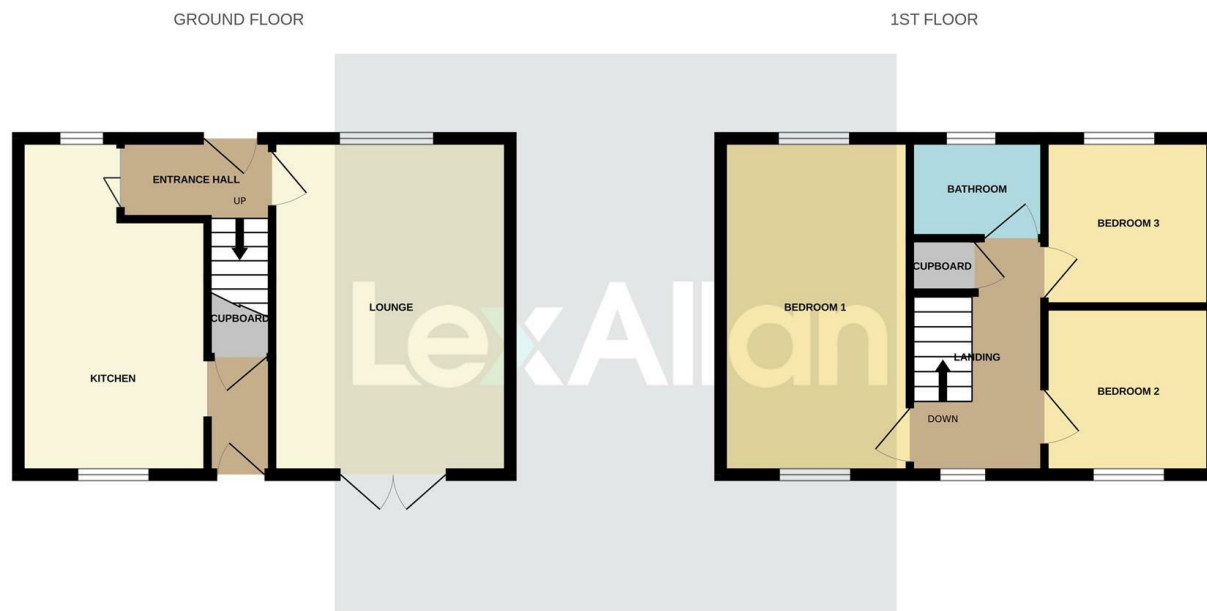
### Tenure (Freehold).

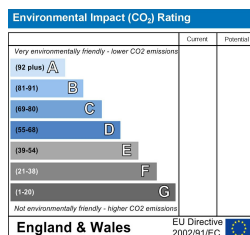
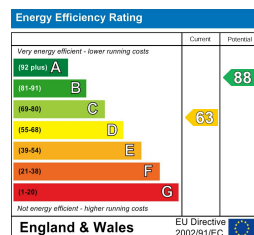
