Driveway to front providing off road parking for three vehicles.

Dining Hall

Spacious room with double doors off to lounge, stairs rise to the first floor with under stair storage, double glazed bay window to front, central heated radiator, oak flooring through.

Lounge

Centred electric fire place with surround, patio door allowing access into the garden, central heated radiator.

Kitchen/Breakfast Room

Variety of wall & base units, sink with drainer, Large Rangemaster style oven with extractor over, plumbing for washing machine, tiled splashback, double glazed window to side along with door access leading to the garden, central heated radiator.
