#### Communal area

Secure and well maintained hall, lift access and stair access leads to the third floor.

#### Entrance Hall

Central heating radiator, intercom and cupboard and doors off.

#### Lounge/Kitchen/Diner

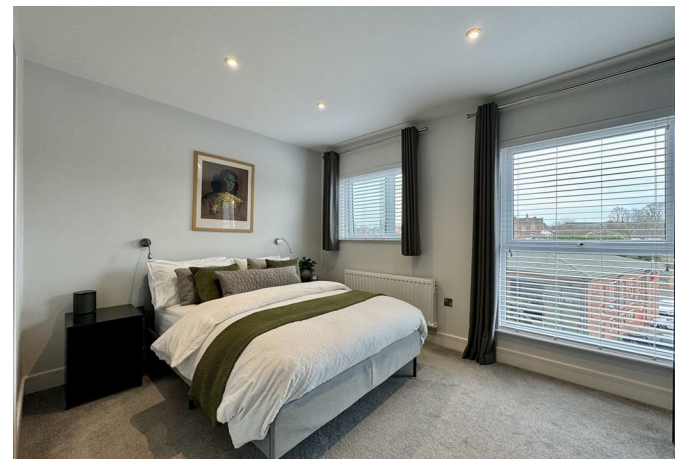

### Tenure (Leasehold).

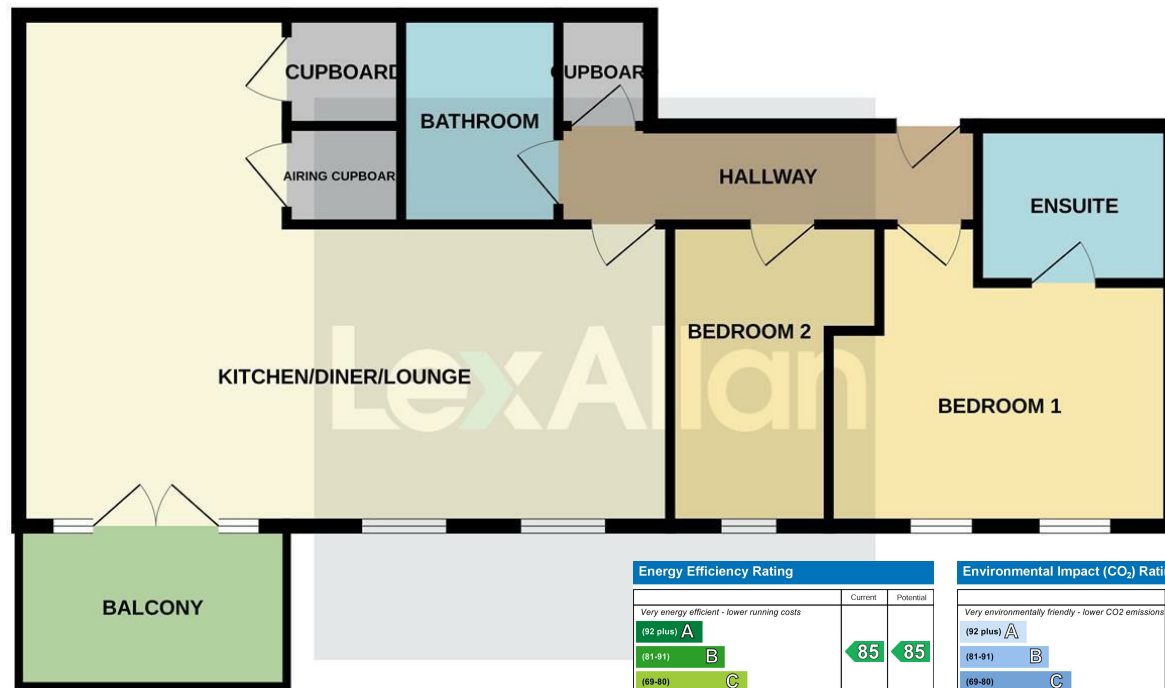
