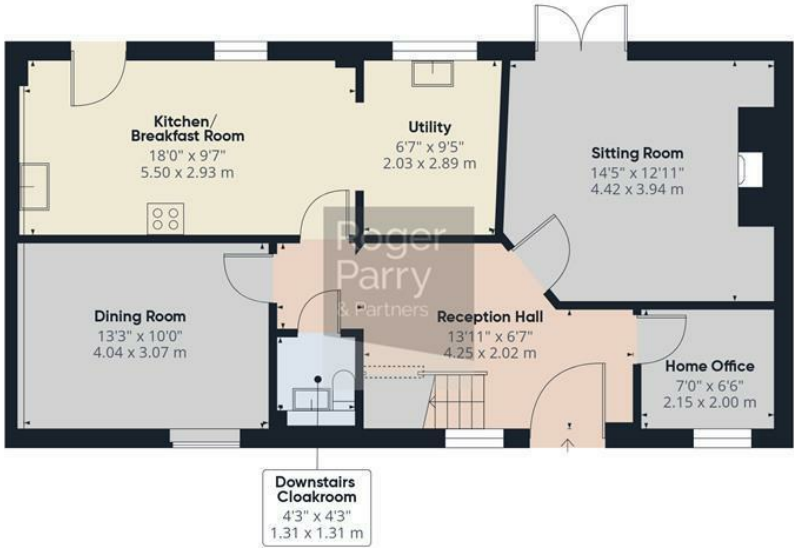

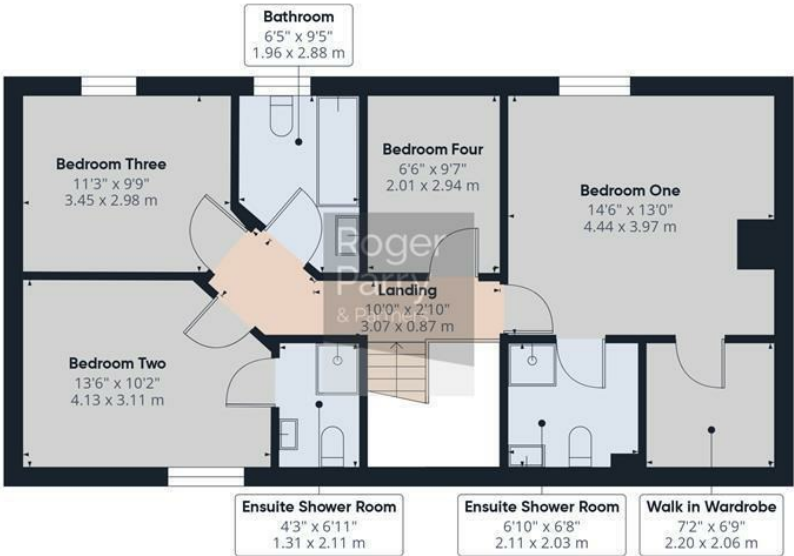
Holding Deposit
