The accommodation briefly comprises:

To the first floor, there are three double bedrooms and a family bathroom.

The village of Berriew is conveniently situated just 5 miles from Welshpool and 9 miles from Newtown, both offering a broader range of shopping and amenities. The county town of Montgomery is only 4 miles away, and the historic town of Shrewsbury is also within comfortable commuting distance. Excellent transport links provide easy access to major airports, including Birmingham, Liverpool, and Manchester.

The main source of heating is electric heaters, with the additional benefit of an oil-burning stove in the living room.
