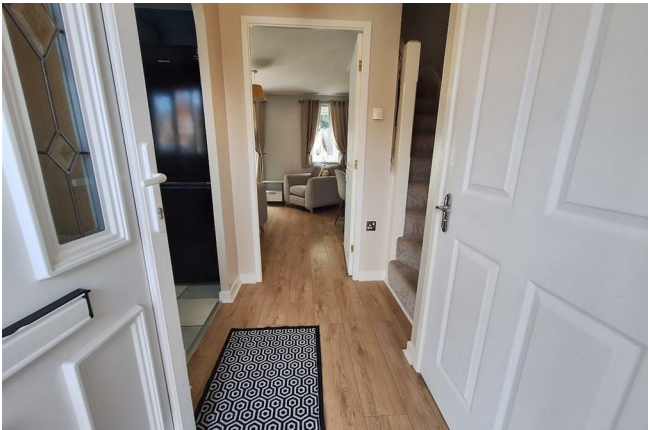

Holding Deposit
