The accommodation briefly comprises: Entrance hall, living room with wood-burning stove, kitchen/diner, ground floor bathroom. On the first floor there are three bedrooms comprising two doubles and one single. Benefiting from Oil central heating, partial double glazing, internal beams, gardens, workshop, garage and parking for two cars. EPC band E. A dog may be considered subject to the landlords approval for an additional rent of £20pcm.

The property is located approximately 4.5 miles from the popular market town of Ellesmere, offering the benefits of a rural location alongside proximity to local facilities and transport links. The villages of St Martins and Gobowen contain a range of shops, a supermarket, pubs and amenities including Primary and Secondary Schools. Criftins primary school is approximately 2 miles from the property. Ellesmere and Oswestry provide additional amenities while easy access onto the A5 and A483 provides links to the town of Shrewsbury and the city of Chester. Gobowen has a train station which provides good rail links.



## **Holding Deposit**

PLEASE READ CAREFULLY.
