The land extends to approximately 22.3 acres (9.02ha) of grassland split into a number of conveniently sized field parcels. The property comprises a mix of flat mowing/grazing land up to sloping hill/upland land suitable for grazing. The property is encompassed by a mature hedgerow and stock netting/wire fence boundary and accessed via gateways off the adjoining council maintained highway. There are a small range of stable outbuildings suitable for equestrian, livestock and/or storage use. The property has a natural water supply in the form of a well which is piped to some of the field parcels.

The property is located between Caersws and Trefeglwys off a minor council highway accessed off the B4569.

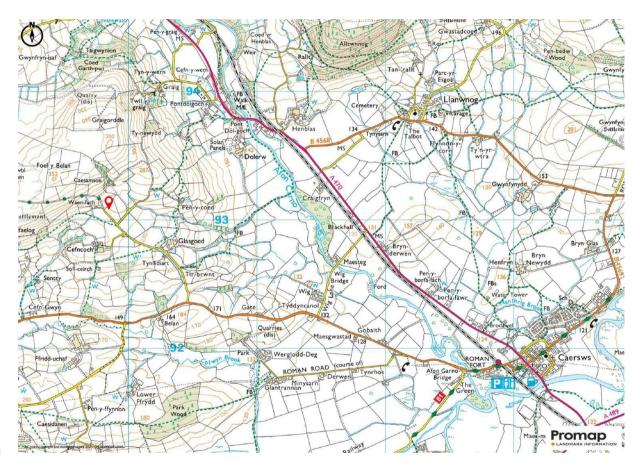
